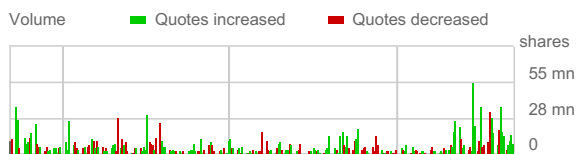

The company's flagship asset is Dubai Investments Park. Operating as a city within a city, Dubai Investments Park consists of an industrial, commercial and residential area spanning 23 km<sup>2</sup>, which is strategically located in close proximity to the EXPO 2020 site, Jebel Ali port and Dubai World Central airport. Dubai Investments Park is currently at a total occupancy rate of 97%.

Dubai Investments has an impressive track record of returning value to its shareholders. A shareholder who invested the money in the Company's IPO in the year 2000 has to date received 14 times of investment value through cash dividends, bonus shares and rights issues.

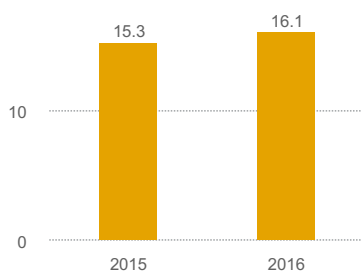

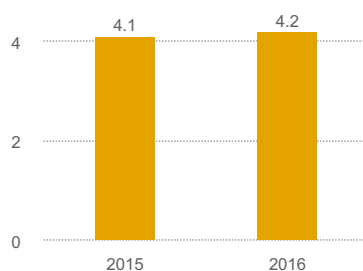

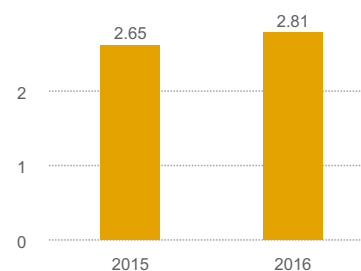
Assets (AED bn)
