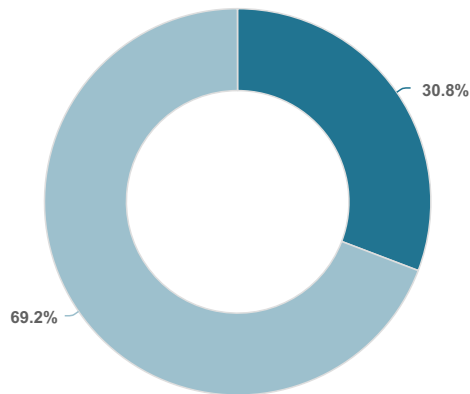
COMPANY PROFILE
